Moorings cost **£35** per year when available. Caravans can be kept on site between 1 April and 31 October for **£100.00**. Annual Camping fee of **£75.00** or a fee for Camping/Caravan at **£4.00** per night with an additional **£1.00** for electrical hook up (Limited numbers). Clubhouse keys are available from the Bosun.

Before membership is considered by the general committee, admission fees, annual subscriptions and boat fees as detailed above must be enclosed with this application. Fees and subscriptions are returnable in full if the application is not accepted.

Boats - All boats sailed on the River Severn require a Canal & River Trust (CRT). For sailing boats this is **£13.00 per boat**, and paid annually through the club (this is a discount rate only available through the club). Owners of cruisers or any boats with motors must apply directly to the **Canal & River Trust**, and are responsible for their own licences. Fees must be paid for all boats sailed or kept at the club. Payment of a boat fee entitles the member to keep the boat in the club boat park. Members are advised that the boat park is liable to flooding, particularly in the winter.

The club is wholly owned by the members, and the payment of the admission fee is the method of buying into the assets of the club, and becoming a full shareholder. The club is open to members at all times, and the normal sailing year is between early March and December.
